The FY 2025-26 Proposed CIP Budget identifies the costs of constructing the following types of projects:

- Street Improvements
- Storm Drainage
- Facilities
- Water
- Sewer

California Government Code, Section 66002 provides that any local agency which levies a Development Impact Fee subject to California Government Code, Section 66001 may adopt a Capital Improvement Plan, which shall indicate the approximate location, size, time of availability, and estimates of cost for these facilities or improvements to be funded with the fees. 
