**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HESPERIA,
CALIFORNIA, AMENDING THE FISCAL YEAR 2025-26 CAPITAL
IMPROVEMENT PROGRAM BUDGET BY APPROPRIATING \$6,663,865 IN
FUND 306 DIF 2018-STREETS, \$680,780 IN FUND 504 SB1 LPP GRANT, AND
\$1,079,594 IN FUND 504 SB1 FORMULA FUNDS FOR THE RANCHERO ROAD
CORRIDOR WIDENING PROJECT PHASE III.**

WHEREAS, Ranchoero Road Improvements – Seventh Avenue to Mariposa Road, C.O. No. 7094, Ranchoero Road Aqueduct Crossing, C.O. No. 7139, Traffic Signal at Ranchoero Road/Maple, Cottonwood, and Seventh, C.O. Nos. 7131, 7146, and 7154 respectively, are collectively referred to as the Ranchoero Road Corridor Widening Project Phase III (Project); and

WHEREAS, except for the aqueduct crossing (bridge) and related work, and work in the bridge adjacent areas, all other work under the project is complete; and

WHEREAS, funding for the Project was established in the Fiscal Year 2025-26 Capital Improvement Program Budget; and

WHEREAS, construction progress is exceeding anticipated milestones; and

WHEREAS, a budget amendment is required to continue services and construction related to the Project in addition to reconciling grant expenditures; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HESPERIA AS FOLLOWS:

Section 1. The foregoing recitals are true and correct.

Section 2. The City Council hereby amends the Fiscal Year 2025-26 Capital Improvement Program Budget by appropriating \$6,663,865 in Fund 306 DIF 2018-Streets, \$680,780 in Fund 504 SB1 LPP Grant, and \$1,079,594 in Fund 504 SB1 Formula Funds for the Ranchoero Road Corridor Widening Project Phase III:
