He also voiced additional concerns regarding traffic near Juniper Elementary School and the unsafe conditions it is creating. Additionally, he shared information about available cooling stations to help keep residents and others safe during the heat wave.

Chair Abreo acknowledged the commissioner's concerns regarding school traffic and offered his professional insight on the matter.
