A RESOLUTION OF THE SUCCESSOR AGENCY TO THE HESPERIA COMMUNITY REDEVELOPMENT AGENCY, APPROVING THE ANNUAL 2026-27 RECOGNIZED OBLIGATION PAYMENT SCHEDULE FOR SUBMISSION TO THE COUNTYWIDE OVERSIGHT BOARD

WHEREAS, pursuant to Health and Safety Code (HSC) Section 34172 (a)(1), the Hesperia Community Redevelopment Agency was dissolved on February 01, 2012; and

WHEREAS, the City of Hesperia elected to serve as the Successor Agency to the former Hesperia Community Redevelopment Agency ("Successor Agency") pursuant to Assembly Bill x1 26 ("Abx1 26") as codified in the California Health and Safety Code ("HSC"); and

WHEREAS, Abx1 26 was amended by Assembly Bill 1484 and Senate Bill 107 (collectively, the "Dissolution Act"); and

WHEREAS, among the duties of successor agencies under the Dissolution Act as amended is the preparation of an annual Recognized Obligation Payment Schedule ("ROPS"), per HSC Section 34177 (i); and

WHEREAS, pursuant to HSC Section 34177(I) of the Health and Safety Code ("HSC"), the Successor Agency must prepare a Recognized Obligation Payment Schedule (ROPS) for each fiscal year period (commencing each July 1), listing the estimated payment amounts for enforceable obligations and the source of funds for each such payment during such fiscal period; and

WHEREAS, each ROPS prepared by the Successor Agency must be submitted to the Countywide Oversight Board (Oversight Board) and the State Department of Finance (DOF) for approval; and

WHEREAS, the County will not make any redevelopment property tax trust fund (RPTTF) distributions to the Successor Agency for use in payment of the obligations listed on the ROPS until the ROPS has been approved by the Countywide Oversight Board and DOF; and

WHEREAS, the Successor Agency has prepared a ROPS for the period of July 01, 2026 through June 30, 2027 which is attached hereto as Exhibit A and the Successor Agency has prepared the Fiscal Year 2026-27 Administrative Budget which is attached hereto as Exhibit B; and

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Hesperia, as Successor Agency to the Hesperia Community Redevelopment Agency, as follows:

- Section 1. The Successor Agency herby finds that all of the facts set forth in this Resolution are true and correct and are a substantive part of this Resolution, incorporated herein by this reference.
- Section 2. The Successor Agency herby approves and adopts the ROPS 26-27 covering the period of July 1, 2026 to June 30, 2027 in substantially the form attached hereto as Exhibit A, as required by the Dissolution Act. The Successor Agency accepts changes made by the Consolidated Oversight Board in advance in order to enable the Successor Agency to submit the ROPS 26-27 to the DOF.

- Section 3. Pursuant to the Dissolution Act, the Successor Agency approves the Fiscal Year 2026-27 Administrative Budget for the period July 1, 2026 to June 30, 2027 submitted herewith as Exhibit B, which is incorporated herein by this reference.
- Section 4. The City Manager or another representative of the Successor Agency is hereby authorized and directed to post a copy of the ROPS 26-27 on the City's website and transmit a copy of this Resolution along with the approved ROPS to the San Bernardino Countywide Oversight Board for consideration and approval.
- Section 5. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original resolutions.
