#### RECOMMENDED ACTION

It is recommended that the City Council Advisory Committee (CCAC) review nominations and select an honoree for the City's Neighborhood Pride Enhancement Program (NPEP).

#### **BACKGROUND**

The NPEP recognizes and rewards Hesperia residents for contributing to the aesthetic appeal of the community by improving or enhancing their home's curb appeal. Neighborhood PEP encourages residents to take pride in their homes, neighborhoods, and the City of Hesperia.

#### **ISSUES/ANALYSIS**

Hesperia residents are encouraged to nominate neighbors who have enhanced the exterior of their home with features such as manicured landscaping, drought-tolerant landscaping, rock-scaping, flowers and trees, driveway resurfacing, window enhancements, attractive exterior paint, or overall curb appeal. One honoree is selected at each quarterly CCAC Meeting, and the winning nominee receives \$1,000 in gift cards, a NPEP yard sign, and community recognition.

# Reason for Nomination:

After having the home painted in 2022, we had to have the septic tank replaced in 2023 which took a toll on our home's curb appeal. Two of the local neighborhood walkers stopped by to compliment our new look and one said that it made her feel happy when she walked by.








