

SUBJECT: Ratification of Declaration of Local Emergency

RECOMMENDED ACTION

It is recommended that the City Council adopt Resolution No. 2025-52 ratifying the existence of a local emergency, as declared by the Director of Emergency Services as required by Government Code Section 8630(b).

BACKGROUND

On Wednesday, December 23, 2025, a storm with unprecedented rain passed through the High Desert resulting in over 7.5 inches of rain in some areas of the City of Hesperia causing extensive damage due to flooding within the City. A preliminary estimate of public and private damage is in excess of \$1 million and expected to increase substantially as the impact of the storm continues to impact the community and residents.

Code Section 2.20.060 of the Hesperia Municipal Code empowers the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when said City is affected or likely to be affected by a public calamity and the City Council is not in session. Therefore, the Director of Emergency Services of the City of Hesperia found that conditions of extreme peril to the safety of persons and property arose within Hesperia caused by flooding, and the Director signed and issued a local emergency declaration, Resolution No. 2025-051, on Friday, December 26, 2025.

The County of San Bernardino and the State of California have also declared a State of Emergency for the area.

ISSUES/ANALYSIS

The City Council's actions to ratify the existence of a local emergency within the City of Hesperia will support the City's ability to seek reimbursement for storm-related activities. If no action is taken, the original Declaration of Emergency will automatically terminate.

RESOLUTION NO. 2025-51

A RESOLUTION BY THE DIRECTOR OF EMERGENCY SERVICES OF THE CITY OF HESPERIA, CALIFORNIA, CONFIRMING THE EXISTENCE OF A LOCAL EMERGENCY

WHEREAS, Section 2.20.060 of the City of Hesperia Municipal Code empowers the Director of Emergency Services, to proclaim the existence or threatened existence of a local emergency when said city is affected or likely to be affected by the public calamity and the City Council is not in session; and

WHEREAS, the Director of Emergency Services, of the City of Hesperia does hereby find:

1.	That conditions of extreme peril to the safety of persons and property have arisen within the City of Hesperia caused by:
	Flood
	(Fire, Flood, Storm, Riot, Earthquake, Energy Outage, or Other Causes)

2. That the City Council of the City of Hesperia is not in session (and cannot immediately be called into session).

WHEREAS, Government Code Section 8630 states:

- (a) A local emergency may be proclaimed only by the governing body of a city, county, or city and county, or by an official designated by ordinance adopted by that governing body.
- (b) Whenever a local emergency is proclaimed by an official designated by ordinance, the local emergency shall not remain in effect for a period in excess of seven days unless it has been ratified by the governing body.
- (c) The governing body shall review the need for continuing the local emergency at least once every 30 days until the governing body terminates the local emergency.
- (d) The governing body shall proclaim the termination of the local emergency at the earliest possible date that conditions warrant.

NOW THEREFORE, BE IT PROCLAIMED that a local emergency now exists throughout the City of Hesperia.

IT IS FURTHER PROCLAIMED AND ORDERED that during the existence of said local emergency, the powers, functions, and duties of the emergency organization of the City of Hesperia shall be those prescribed by state law, by ordinance, and resolutions of this city, and by this city's Emergency Plan, as approved by the City Council.

Local Emergency is declared on December 26, 2025 at 2:30 pm.

RESOLUTION NO. 2025-52

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HESPERIA, CALIFORNIA, RATIFYING THE DIRECTOR OF EMERGENCY SERVICES PROCLAMTATION OF EXISTENCE OF A LOCAL EMERGENCY ON.

WHEREAS, the California Government Code §8634 authorizes the City Council of the City of Hesperia to promulgate orders and regulations necessary to provide for the protection of life and property; and

NOW THEREFORE, BE IT RESOLVED BY THE HESPERIA FIRE PROTECTION DISTRICT BOARD OF DIRECTORS AS FOLLOWS:

Section 1. All facts as set forth above are true and correct.

Section 2. The City's Declaration of a Local Emergency issued by the Director of Emergency Services of the City of Hesperia on Friday, December 26, 2025, is hereby ratified and is in full force and effect until such time as the Declaration is terminated.

Section 3. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
