### **RECOMMENDED ACTION**

It is recommended that the City of Hesperia, Successor Agency to the Hesperia Community Redevelopment Agency, Hesperia Housing Authority, Community Development Commission, Hesperia Fire Protection District, and Hesperia Water District Council/Boards/Commissions approve an amendment to the existing Professional Services Agreement with the independent certified public accounting firm CliftonLarsonAllen (CLA) LLP, in the amount of \$30,275, for a total not-to-exceed amount of \$157,175, to include services to assist with implementing the new lease standard, Governmental Accounting Standards Board (GASB) 87.

### BACKGROUND

CLA is the City's current auditor, and the firm has extensive experience in governmental auditing and a deep familiarity of the City's accounting structure. In June 2022, a Professional Services Agreement was approved in the amount of \$126,900 for the performance of an audit of the City and the required State reporting for the fiscal year ended June 30, 2022.

### **ISSUES/ANALYSIS**

The Governmental Accounting Standards Board (GASB) continously reviews generally accepted accounting principles (GAAP) and issues standards, typically called GASB Statements, that must be implemented by the City. The new prominent standard that must be included in the FY 2021-22 Annual Comprehensive Financial Report (ACFR) is GASB Standard 87 Lease Accounting (GASB 87). GASB 87 establishes a single model for lease accounting based on the foundational principle that leases are financings of the right to use an underlying asset; eliminates the distinction between operating leases and capital leases; and applies to contracts not explicitly identified as leases, but that meet the definition of a lease. CLA, as the eigth largest accounting firm in the nation, offers solutions for GASB 87 implementation. Since CLA is the City's current auditor, utilizing the firm for GASB 87 implementation will offer a seemless and efficient implementation of the standard. The first year costs include identifying and classifying leases, as well as lease accounting software. Cost will decrease in year 2 and after as the analytical work needed for implementation will be completed. It is anticipated year 2 costs will be approximately \$6,000.

### RECOMMENDED ACTION

It is recommended that the City Council authorize the City Manager to approve the procurement of one (1) new skid steer and enter into a purchase agreement with Apex Rentals, in an amount not-to-exceed \$71,541.

### BACKGROUND

The City of Hesperia currently owns one skid steer (loader). An additional loader is required to clear storm drains effectively, one on each side. A second skid steer is rented each fiscal year, which is costly and often difficult to locate during periods needed. In addition, the new skid steer includes a mower attachment that is to be used to abate overgrown vegetation at City owned properties.

### **ISSUES/ANALYSIS**

Typically, a formal bid would be prepared for interested vendors to provide pricing with the lowest responsible/responsive bid presented to City Council for authorization prior to purchasing the equipment. Due to current economic conditions, vendors are unwilling to hold prices on current and future inventory as demand outpaces supply due to the industry experiencing continued supply chain disruptions. In addition, manufacturing costs and freight charges are continually rising due to the price increases of raw materials and fuel.

The Streets Maintenance Program is proficient with the standard operating bucket controls and has extensive experience working with Kubota machinery. In addition, compatibility issues would arise should the City purchase a skid steer other than Kubota. The City owns several skid steer attachments that are specific to Kubota machinery. The purchase of additional mounting hardware would be required to retrofit Kubota attachments to another manufacturer's skid steer. The City of Hesperia solicited a quote from Apex Rentals, the local Kubota dealer, located in Hesperia.

### **FISCAL IMPACT**

Funding for one (1) skid steer is included in the Fiscal Year 2022-23 Streets Maintenance Adopted Budget.

### **RECOMMENDED ACTION**

It is recommended that the City Council approve the award of a Professional Services Agreement (PSA) to three professional engineering design firms to provide On-Call Engineering Services for roadway improvement projects funded by the City's annual Community Development Block Grant (CDBG) allocation for an initial term of three (3) years as follows:

Psomas	\$350,000
Angenious Engineering Services	\$350,000
Onward Engineering	\$350,000

### BACKGROUND

The City's annual Capital Improvement Program (CIP) Budget includes the construction of roadway improvement projects that are funded one hundred percent (100%) by the U.S. Department of Housing and Urban Development (HUD) through its CDBG Program. The proposed roadway improvements normally require the preparation of environmental documents, design surveying, geotechnical investigations, preparation of plans and specifications, and construction engineering services. Due to the extensive documentation effort and onerous regulatory burdens placed on projects that receive CDBG funding, staff solicited for these services separate from the engineering services required for all other projects, which are funded with local dollars.

Soliciting for professional contract services is a lengthy process of roughly 3 to 4 months. Rather than preparing a Request for Proposal (RFP) and going through the RFP review process for each individual project, it is more efficient and cost-effective to have consultants "on-call" and available when such services are needed. Further, this method shortens the duration needed prior to start of design or construction of a project. HUD stipulates that CDBG Program funds received by the City must be spent in a timely manner (within one year). Having engineering consultants' on-call shortens the project completion time by 3 to 4 months, which is critical to meet the timeliness requirement. The on-call process has been utilized by the City in the past and has been proven to provide timelier project implementation as well as reduce contract administration time and costs. Every roadway improvement project identified in the CIP that is funded by CDBG Program funds will require professional engineering services throughout the duration of the various phases of the project from preliminary engineering through construction completion.

### **ISSUES/ANALYSIS**

The Public Contract Code requires contracts for professional engineering services to be awarded based on qualifications of a firm. Staff solicited professional on-call engineering services by issuing a Request for Qualifications (RFQ) through a formal process utilizing Public | Purchase, the City's online site. A total of seven Proposals were received and reviewed by a selection committee. The Proposals were evaluated based on certain criteria such as past experience, technical expertise and approach to the scope of work. The firms were ranked by the selection committee as follows:

Typical engineering design costs on roadway improvement projects range from 10% to 18% of the estimated project construction cost. Provision of environmental services, geotechnical services and other construction engineering services will typically add another 12% to the total costs. Smaller projects trend towards the higher end of the scale. For example, the City's annual CDBG roadway improvement project typically costs between \$750,000 and \$1.0 million. The engineering costs for such a typical project would probably range from \$225,000 to \$300,000. Staff estimates that the professional engineering costs for each individual project over the next three years will be a maximum of \$300,000.

Therefore, staff recommends agreement amounts of \$300,000 each for Psomas, Angenious Engineering Services, Inc., and Onward Engineering for the initial three-year period. Awarding the three contracts will not require the City to utilize the entire contract amount, actual expenditures will be based on cost proposals submitted by each consultant for each individual project for a Lump Sum, not-to-exceed amount.

### **FISCAL IMPACT**

Funding for various projects is budgeted each year in the Adopted CIP Budget. Projects budgeted each fiscal year will include adequate appropriation authority for the engineering services needed on a project.

### **RECOMMENDED ACTION**

It is recommended that the City Council adopt Resolution No. 2022-58 approving the Fiscal Year (FY) 2022-23 Project List to be funded by SB-1: The Road Repair and Accountability Act.

### BACKGROUND

On Wednesday, March 29, 2017, Governor Jerry Brown announced a transportation funding agreement. The agreement was passed by the State Legislature and signed into law in April of 2017 as Senate Bill 1 (SB-1) or the Road Repair and Accountability Act of 2017. SB-1 will be funded by various mechanisms including a 12 cent gas excise tax increase, a reset price-based excise tax at 17.3 cents, a 20 cent diesel excise tax, a 4% diesel sales tax increase, a \$25-\$175 annual transportation improvement fee based on vehicle value, and a \$100 annual zero emissions vehicle fee. From these sources, SB-1 is expected to provide \$5.2 billion annually and \$15 billion for local streets and roads over the next ten years. Specifically, local agencies will be funded through the Road Maintenance and Rehabilitation Account (RMRA) which consists of the new gas tax, the transportation improvement fee, and part of the diesel excise tax. The local share will be split evenly between cities and counties with city revenues being allocated per capita. The City of Hesperia will receive an estimated \$2,127,010 for FY 2022-23.

SB-1 will provide investments to make significant improvements to the State's highway system as well as local transportation facilities in disrepair. Cities and counties will use SB-1 funds for complete streets projects, railroad grade separations, traffic control devices, increasing mobility options for residents, and increasing access to multi-modal transportation options by expanding transit, bicycle, and pedestrian friendly opportunities. However, the main focus of RMRA is to improve deteriorating roads throughout the state through maintenance and rehabilitation projects as well as critical safety projects. Therefore, SB-1 requests that, to the extent possible, local agencies prioritize basic maintenance and safety projects.

### **ISSUES/ANALYSIS**

SB-1 includes accountability and transparency measures to ensure the residents of the City are aware of the projects proposed for funding in our community. Cities and counties will adopt a project list by resolution each year and provide year-end reporting on completed projects including necessary ammendments if applicable. Prior to receiving funds, cities are required to annually approve a list of all projects by resolution that are proposed to receive funding from the RMRA.

The project list must include a description and the location of each proposed project as well as the estimated useful life of the improvement.

City staff will submit a list of projects to the California Transportation Commission that includes projects approved by the City Council. The project list for FY 2022-23 will include relisting the following projects: FY 2021-22 Street Improvement Project which includes; Cottonwood Avenue which includes slurry seal and/or micropaving of asphalt on Cottonwood Avenue between Main Street and Willow Street; and Jacaranda Avenue which includes select removal and replacement and slurry seal and/or micropaving of asphalt on Jacaranda Avenue between Outer Bear Valley Road and Eucalyptus Avenue. Maple Avenue Rehabilitation Project which consists of select removal and replacement of asphalt on Maple Avenue between Main Street and Cedar Avenue.

### FISCAL IMPACT

There is no direct fiscal impact as a result of this subject item. This action simply approves the FY 2022-23 SB-1 Funding Project List for the purpose of receiving and expending SB-1 RMRA funds.

### RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HESPERIA, CALIFORNIA, ADOPTING THE FISCAL YEAR (FY) 2022-23 PROJECT LIST TO BE FUNDED BY SENATE BILL-1: THE ROAD REPAIR AND ACCOUNTABILITY ACT

**WHEREAS**, Senate Bill (SB-1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor in April 2017 in order to address the significant multi-modal transportation funding shortfalls statewide; and

**WHEREAS,** SB-1 includes accountability and transparency provisions that will ensure the residents of our City are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

**WHEREAS**, the City must include a list of all projects proposed to receive funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB-1, in the City budget, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

**WHEREAS,** the City will receive an estimated \$2,127,010 in RMRA funding in FY 2022-23 from SB-1; and

**WHEREAS,** the City submitted a project list that includes projects that are in the Adopted FY 2022-23 Capital Improvement Program Budget which will allocates all \$2,127,010 to the FY 2022-23 Street Improvement Project; and

**WHEREAS,** the funding from SB-1 will help the City maintain and rehabilitate streets, bridges, and add active transportation infrastructure throughout the City; and

WHEREAS, maintaining and preserving the local street and road system in good condition, as well as the installation of traffic control devices, will reduce traffic drive times and traffic congestion, which leads to a reduction on vehicle emissions helping the State achieve its air quality and greenhouse gas emission reduction goals, and will improve bicycle, pedestrian, and vehicular safety; and

**WHEREAS,** restoring roads before they fail also reduces construction time which results in less air pollution from heavy equipment and less water pollution from site run-off; and

**WHEREAS**, the SB-1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using modern technology, materials and practices, will have significant positive benefits statewide.

**NOW THEREFORE**, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HESPERIA AS FOLLOWS:

Section 1. The foregoing recitals are true and correct.
