Any person affected or concerned by these proposals may submit written comments to the City Clerk's office before the public hearing or appear and be heard in support of or in opposition to the proposals at the time of the public hearings. If you challenge these proposals in court, you may be limited to raising only those issues you, or someone else raised at the public hearings described in this Public Hearing Notice, or in written correspondence delivered to the City Clerk at, or prior to the public hearings.

FOR THE FOLLOWING PURPOSE:

1. Consideration of the Development Impact Fee Study, a comprehensive evaluation of the City's infrastructure needs to accommodate new development, and adoption of Resolution No. 2018 26 reflecting proposed revised Development Impact Fees set during the April 17, 2018 City Council meeting, in the Capital Improvement Development Impact Fee Categories of Fire Suppression Facilities, Vehicles, & Equipment, Police Facilities, Animal Control Facilities, City Hall Facilities, Records Storage Facilities, Drainage Facilities and Transportation Facilities that will amend the Fees for Single Family Residence units, Multi-Family Residence units, Commercial/Office/Retail sites per 1,000 SF, Industrial sites per 1,000 SF, and Hotel/Motel sites per room. Pursuant to Government Code Section 66016, data supporting the proposed fee schedule, estimated costs and intended revenue sources to provide the services and public facilities are available for review in the City Clerk's Office 10 days prior to the public hearing.
