Any person affected or concerned by these proposals may submit written comments to the City Clerk's office before the public hearing or appear and be heard in support of or in opposition to the proposals at the time of the public hearings. If you challenge these proposals in court, you may be limited to raising only those issues you, or someone else raised at the public hearings described in this Public Hearing Notice, or in written correspondence delivered to the City Clerk at, or prior to the public hearings.

FOR THE FOLLOWING PURPOSE:

- 1. Consideration of Resolution No. HWD 2021-13 to adopt the public draft of the 2020 Urban Water Management Plan (UWMP) as written or as amended during the public hearing and authorize submittal of the UWMP to the California Department of Water resources as required by the Urban Water Management Planning Act.
- 2. Consideration of Resolution No. 2021-04, confirming parcels of land upon which unpaid fees for services, and enforcement and abatement costs remain, and Resolution No. 2021-05, requesting that San Bernardino County place the unpaid fees for services, and enforcement and abatement costs on the property tax rolls.
- 3. Consideration of Ordinance 2021-06, approving a Trench Moratorium to prohibit utility cuts, trenches and potholing on the City's newly constructed, reconstructed, and rehabilitated streets and roadways.
- 4. Consideration of Ordinance 2021-07, adopting Chapter 5.80 of the Hesperia Municipal Code, regulating tobacco product sales, requiring the licensure of tobacco retailers.
