Member Holland motioned to direct staff to craft an ordinance banning all commercial application under AUMA and regulate indoor growing provisions and ban outdoor growing for AUMA.

Direction was given by Council Member Swanson to protect privacy of those receiving home delivery for medical marijuana.

Member Holland motioned that staff should develop an ordinance that would allow for medical marijuana delivery services as is deemed appropriate to both originate from and delivery to residents within the City of Hesperia, but not dispensary store fronts attached to delivery.
